Do not send entries by any method requiring signature for delivery. An email will be sent to you to confirm your entry and scheduled appointment.

Additional Rules & Information:

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Owners or their Agents are solely responsible for the presence of their dog(s) at the Test arena. Judges are not required to wait for dogs. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. No entry fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, extreme weather conditions, or any other cause beyond the control of the event committee

Steele Away Farm is a small family farm with horses, chickens, and sheep. There are many gates on a farm. If they are open, leave them open. If they are closed leave them closed. If you go through a gate, return it to the way it was. Do not feed the livestock unless instructed. Stay off farm machinery and out of farm buildings. Clean-up after your dog and DO NOT let them urinate on the hay bales (Hay is food for the livestock). Exhibitors must have positive control of their dog at all times. Dogs MUST be on a leash or crated during the event.

Dogs Eligible to Enter the FDC Test:

The FDC test is open to all dogs at least 9 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners Program.

Open to all breeds. Females in season may not enter. Dogs with physical challenges (including amputees) are eligible to enter provided, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the test. A dog may enter only once per event. An event is defined by an event number.

Alternates:

Entries will close when the numerical limit has been reached. All entries received after the numerical limit is reached and before the closing date shall be added to an alternate's list. Entries shall be added to the alternate's list in the order that they are received. Alternates that do not run or do not have the opportunity to run shall have their entry fees returned. Entrants on the alternate's list must check in with the Secretary no later than 30 minutes before the commencement of the event.

Livestock Death/Injury: Exhibitors are responsible to pay for any livestock death caused by their dog(s). Replacement value for sheep/goats is \$250 and \$50 for chickens. In case of any injury to stock caused by the dog, the exhibitor assumes total responsibility for any damage and will pay the full veterinarian bill or the cost of replacement.

DIRECTIONS TO THE TEST SITE

From I80 East or West – take the exit for I505 North to Redding. Exit at Midway Road, turn left at the stop sign. At the next road, turn right onto Hartley Rd. Go about .7 mile, turn left into the driveway.

From I505 South – Take the Midway Road exit, turn right at the stop sign. At the next road, turn right onto Hartley Rd. Go about .7 mile, turn left into the driveway.

COVID - Restrictions

CSKC asks that only entered dogs and handler(s) attend.

If you have been in large crowds in the last two weeks, please do not attend. Please make sure you do not have a cough, sore throat, shortness of breath, or temperature before attending.

Masks MUST be worn at ALL times. Masks must cover both nose and mouth. If you choose to wear a Face Shield you must still wear a Mask

Social distancing of 6 feet must be maintained with anyone not in your immediate family.

Follow all directions or instructions given to you by CSKC members or the Judges.

There is no food available onsite. Bring your own shade.

If you break these rules you will be required to leave immediately.

With COVID-19 still active, CSKC will run things a little differently. The FDC test will be a 'show & go'. So, as soon as your 2 runs are over, please check the secretary's table for results and you may pick up your score sheets and ribbon. Someone will be there to hand them to you. CSKC will have a photo op station so that you can take pictures of your dog's accomplishment!

Cancellation of trial

If the COVID situation should cause the Farm Dog Certification to be cancelled CSKC will do so and refund your entry.
